RESOLUTION AUTHORIZING THE HEALTH SERVICES AGENCY TO SIGN STATE
STANDARD AGREEMENTS INCLUDED ON THE 2025-26 CONTINUING
AGREEMENTS LIST

WHEREAS, the County of Santa Cruz contracts with the State of California for various health programs; and

WHEREAS, the State of California requires local governing body approval to enter into contractual agreements; and

WHEREAS, the Board of Supervisors of Santa Cruz County approves continuing agreements during fiscal year 2025-26 budget hearings, including those between the State of California and the County of Santa Cruz for health programs as outlined in Exhibit A; and

WHEREAS, the State of California requires that the Exhibit A include current State contract numbers as a prerequisite for contract execution; and

WHEREAS, the Board of Supervisors of Santa Cruz County desires to authorize the Health Services Agency to update State contract numbers and estimated fiscal amounts for contracts listed in Exhibit A, on an as-needed basis, without further Board approval; and

WHEREAS, the Board of Supervisors of Santa Cruz County desires to authorize the Health Services Agency to execute agreements between the State of California and the County of Santa Cruz as included on the 2025-26 Continuing Agreements List for purposes of fulfilling health program objectives, including all amendments to existing agreements and all successor agreements for the same services.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, that the County of Santa Cruz Board of Supervisors hereby authorizes the Health Services Agency Director or the Director's designee to sign and execute standard agreements with the State of California listed in Exhibit A which are included on the 2025-26 Continuing Agreements List as approved by said Board during budget hearings for 2025-26, including amendments to existing agreements and any successor agreements for the

same services, and additionally authorizes the Health Services Agency Director or the Director's designee to update State contract numbers and estimated fiscal amounts on an as-needed basis, without further Board approval, for contracts listed in '2025-26 State Agreements: Exhibit A'.




