BE IT RESOLVED AND ORDERED by the Board of Supervisors of the  
County of Santa Cruz as follows:

Section 1. Benefit assessments/service charges for parcels within  
Westdale Drive, County Service Area No. 21, for the 2025/2026 fiscal year and  
for each fiscal year thereafter unless increased by the Consumer Price Index, all  
Urban Consumers for the San Francisco-Oakland-Hayward Area or changed by  
Resolution of the Board adopted after any public hearing and proceedings  
required by law, shall be as follows:

\$168.86 per year per parcel


Section 2. Benefit Assessment/Service Charge Exemptions: Benefit  
assessments/service charges will not be levied on parcels in the following  
categories:

1. Common area parcels.
2. Parcels with an assessed valuation of \$5,000.00 or less.
3. Unbuildable parcels as determined by Planning and  
Environmental Health regulations.
4. Parcels used solely for, and dedicated to, providing private water  
supply to residential areas (well or tank sites).



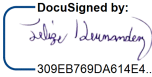
