RESOLUTION SETTING HEARING ON ASSESSMENTS TO FUND
ROAD MAINTENANCE AND OPERATIONS WITHIN
COUNTY SERVICE AREA NO. 46, PINECREST

WHEREAS, the Board of Supervisors has determined the nature, extent and cost of the extended services to be provided in County Service Area No. 46, Pinecrest; and

WHEREAS, Proposition 218 requires a duly noticed public hearing be held as part of the election process.

NOW, THEREFORE, the Board of Supervisors of the County of Santa Cruz resolves and orders that on Tuesday, April 8, 2025, at 9:00 a.m. or thereafter in the Board Chambers, Room 525, County Governmental Center, 701 Ocean Street, Santa Cruz, California, the Board of Supervisors will conduct a public hearing on the proposed benefit assessment/service charge rates for County Service Area No. 46, Pinecrest, for the 2025/2026 fiscal year.



From time to time, County of Santa Cruz (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. 
