NOW, THEREFORE, the Board of Supervisors of the County of Santa Cruz resolves and orders that on Tuesday, April 8, 2025, at 9:00 a.m. or thereafter in the Board Chambers, Room 525, County Governmental Center, 701 Ocean Street, Santa Cruz, California, the Board of Supervisors will conduct a public hearing on the proposed benefit assessment/service charge rates for County Service Area No. 25, Viewpoint, for the 2025/2026 fiscal year.






