When multiple things happen like this, insurance prices escalate along with inflation.

Local construction companies about 20 years later offered to dredge the creek for one million dollars. But environmental regulations postponed the dredging which caused more flooding along with more fish to rot. Finally, it got dredged for about 5 million dollars spent by the taxpayers again due to the environmental review after old time farmers and ranchers already did a better job at taking care of it at no expense to the American taxpayers. Pescadero Marsh is just one little pimple of the country that sets the example of all the failed policies that need to be fixed all over the entire United States.

Local people complained for years, but left-wing radicals chose their failed government control ideologies and ignored us.
