## THIRD AMENDMENT TO AGREEMENT BETWEEN SANTA CRUZ COUNTY AND KARPEL SOLUTIONS FOR PROSECUTORbyKarpel®

This third Amendment to the Agreement (Originally Referenced as #DOC-2022-27; Annual Contract number: 25C4539) is made and entered into by and between the County of Santa Cruz, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Karpel Computer Systems Inc. (hereinafter referred to as "KARPEL SOLUTIONS"). COUNTY and KARPEL SOLUTIONS shall hereinafter collectively be referred to as the "PARTIES" and generically as a "PARTY."

### RECITALS

- A. KARPEL SOLUTIONS and COUNTY entered into an initial Agreement, with exhibits and incorporated documents, for Software Products and Services effective January 11, 2022, (the "AGREEMENT") with respect to PROSECUTORbyKarpel® ("PbK") and DEFENDERbyKarpel® ("DbK"); and
- B. KARPEL SOLUTIONS and COUNTY amended the AGREEMENT effective March 22, 2022, nullifying the portion of the original agreement pertaining to the Santa Cruz County Public Defender's Office; and
- C. KARPEL SOLUTIONS and COUNTY amended the AGREEMENT effective June 25, 2024, to pay for unforeseen costs incurred related to critically needed additional terabyte (TB) storage capacity; and
- D. KARPEL SOLUTIONS and COUNTY wish to further amend the AGREEMENT as set forth herein; and
- E. The AGREEMENT allows the PARTIES to amend the AGREEMENT upon a mutual signed written agreement.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the PARTIES, with the intent to be legally bound, agree as follows:

1. Modification of Terms: The attached Karpel Solutions Invoice #69873, dated November 12, 2024, (marked as Exhibit C), contains additional charges and/or modified fees beyond those previously authorized by the first executed ADDENDUM to the AGREEMENT (Doc-2022-263). The additional charges and/or modified fees contained in Exhibit C shall apply commencing November 1, 2024, are hereby incorporated into the AGREEMENT by reference, and are deemed to be part of the AGREEMENT continuously, as set forth in full herein, unless and until the AGREEMENT is terminated and/or is otherwise amended upon mutual signed written agreement by the PARTIES. Exhibit C contains all outstanding charges and/or fees owed by COUNTY to KARPEL SOLUTIONS. The purpose of the additional charges and/or modified fees contained in Exhibit C is for KARPEL SOLUTIONS to address an Annual PBK Hosting Fee increase, provide
