

AMENDMENT NO. 1 TO AGREEMENT 24C4900

The parties hereto agree to amend that certain Agreement dated October 21, 2023, by and between the COUNTY OF SANTA CRUZ (“COUNTY”) and Big Basin Water Company Inc., C/O Silver & Wright LLP, Court Appointed Receiver (“CONTRACTOR”). This Amendment is necessary to allow flexibility in the allocation of funds among individual Task Budgets in order to respond to changing operational needs. The resources and expenditures required to ensure continuity of operations for the Big Basin Water System have evolved since the execution of the original Agreement and are anticipated to continue to change over time.

The not-to-exceed (NTE) amount of \$850,000 set forth in the Agreement shall remain unchanged and in full force and effect. This amendment is intended solely to permit flexibility among Task Budgets and shall not be construed to increase COUNTY’s maximum financial obligation under this Agreement.

NOW THEREFORE, the Parties mutually agree as follows:

1. Exhibit B – Budget & Schedule is hereby amended to add the following provision:

The individual task-specific budget allocations shown on Fig. 1. Budget may be modified as necessary at COUNTY’s sole discretion without the need for further written amendment provided that the total compensation paid under the Agreement does not exceed the established NTE amount of \$850,000. Any reallocation of funds between Tasks shall be documented administratively by COUNTY in the contract file.

2. All other provisions of said Agreement shall remain the same and in full force and effect.

In the event of a conflict between the provisions of this Amendment and the Agreement, the provisions of this Amendment shall govern.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Santa Cruz (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
