Re: Victoria Todd

Hello Sube,

Thank you for finally informing me that you got my complaints. The **BHD client is still kept gravely disabled** and BHD refused my demands to manage her for stabilisation and rehabilitation. My daughter's mind is corrupted and controlled by the MK-Ultra program to do what the authorities want her to do against her wellbeing and safety. The heavy brainwashing was done in three terms from 2014 to 2018 under PG at a locked facility in Angwin, Napa County under criminally minded and charged psychiatrist Nathan Thuma. She was deeply confused and obstructed for decades by the BHD mistreatment and mismanagement and under county **Quality Improvements and APS cover up**.

If our concerns and complaints in the past since 2014 were investigated, my daughter will be fine and could finish her higher education at UCSC by now that has one year left for two BA in art and piano. Victoria had the ability to complain after her first PG conservatorship in 2014 and after the second in 2015, because she was able to analyse and evaluate that Public Guardian (PG) is only for locking up in a psychiatric facility, out of Santa Cruz County, in the middle of nowhere, with no fresh air, no visitors from community and constantly stolen things, like Kindle, radio, CD player and even special favorite food sent to her with Prairie Garcia was not getting into her hands that what Daniel Long MHCS and Prairie Garcia MHCS did to her and she complained. The result of her complaint was ongoing retaliation and BHD neglectors were getting their salary increased to continue their outrageous neglect. Victoria was punished for her complaints and was targeted for extended punishment by fabricated false accusations for 148(a) by police officers against gravely disabled homeless evaluated by Telecare on October 28, 2014 and pushed back on the streets again for a second one 148(a) in February 2015 obstructing police officers in gravely disabled condition both without actual crime the BHD and APS authorities used to keep both to torture her

continuously by court issuing warrants for missing hearings for notifications that have not been served to PG conservatee and to homeless between PG conservatorships until 2017. PG took an action for illegal electrical shock to disable her brain. Assigned to her attorney in criminal cases did nothing and instead assisted her abusers.

Victoria did not get her voucher section 8 in 2015, 2016 because Prairie Garcia got my daughter to hide in a shelter and blocked communication with her for me. Prairie Garcia did not coordinate her care, her affairs and won't bring her to the appointment with the Housing Authority, nor to the court for hearings. Conspiracy was set up between BHD and HA do not consider my DPOA on behalf Victoria either. Prairie Garcia was the one who refused to give me Victoria's belongings and documents when Prairie Garcia and PG lost my daughter from Telos in 2014 and won't look for her. Documents never been returned, belongings never been given back that I was buying and bringing to Napa County in 2014 where she was locked up under dangerous and bad environment for autistic without any necessity to be locked up in the psychiatric prison, in the middle of nowhere surrounded by Paranoid Schizophrenics, in conspiracy from me, because **as a mother I had a priority to conserve my biological daughter and not the county PG**. Prairie Garcia never was trying to bring Victoria back under the roof when she was getting lost and I was the one who filed a missing person reports. Her conservator Vivian Van Dal and Public Guardian Vanessa Bertsche Shelton refused to protect her too. Victoria was hiding in the woods on the west side after the first conservatorship and after the second one. I was filing missing person reports and was looking for Victoria through the county woods and only Park Rangers helped me to look for her and put flyers around. I asked Prairie Garcia to give me her belongings and documents: Green Card, CA ID and she never ever gave me anything, never gave it back to me. I was getting a lot of obstacles to replace all those documents. Prairie Garcia created issues for Victoria to get together with me and get on time for the appointments. It was not my job, it was the authorities' highly paid job to manage care and assist Victoria with her affairs and treatment. Instead, Victoria never was helped. **She was also blocked from SS benefits and Medicare**. Food Stamps were only given when I helped her to get it and as soon as I helped to get it, they stopped her FS, influencing her to withdraw authorization for me. The authorities were taking advantage of her naivety and vulnerability and were making fun of my autistic daughter. She never was getting food stamps uninterrupted during the 12 months since 2011. She had not been getting her FS at all during three PG conservatorships, her conservators told the judge that she did not need it. I was buying her favorite food for her to visit when she was in any facility. When I finally got her from Napa County back to Santa Cruz to the 7th Avenue facility in December 2017 she inherited Parkinsonism under the power for mistreatment of PG conservatorship. 7th Avenue allowed me to visit her every day and every day was bringing her favorite food. She did not have FS from 2020 to November 2023, because the BHD management delegated Ernesto Servantes, unlicensed MHCS, to visit Victoria in her apartment that I helped her to get and actively influencing her to file a RO against me to isolate her from my help and alienate her from my protection.

The next thing happened to Victoria after she lost my protection on August 8, 2020, she lost everything, FS, voucher section 8 that she was waiting for since 2008 and got in on April 2020 in return for obligations to break relationship with me and help them to oppose my Petition for

conservatorship, Unfortunately, my autistic daughter is not able to resist violence and there is no doubt that she was given some substance to make her do what they want her to do. In the next secret punishment by eviction in 2021, all her belongings were brutally appropriated by the landlord and she was evicted in pandemic time June 10, 2021 back on the street. Ernesto Cervantes who influenced and managed her to file RO to leave her without my protection, did not help against eviction, neither Prairie Garcia nor Elidia Giron. They were all acting deaf and blind. She came to me, fell on my arms heavily schizoaffective of all that out of care stress that she was put under by BHD. The year of 2024, is the first year since 2011 that she had FS for 12 months, because I got it for her.

I repeat again, nothing good my daughter learned from BHD care, nothing good was taught by BHD and she got no assistance from BHD, APS and HSD. She never had any other Social Worker to help her with her affairs, but three PG conservatorships to lock her up in Napa County, Angwin in the middle of nowhere, on top of a mountain that I and nobody else have not been able to visit her. She was assigned and treated by dangerous deaf and blind Psychiatrists and deaf and blind MHCS. Her **high level Autism Asperger syndrome was under terror and she developed Severe Autism**, because the BHD team and HSA team coached her against my Petition for Conservatorship, **my third Petition in 2019. They coached her to scream repeatedly out loud:"I am not Autistic! I am not Autistic! I am an adult! I am an adult!"** when nobody asked her anything and nobody ever gave her a word to say and a chance to talk, but she was scared, panicked and influenced to help BHD employees to hide her real condition, diagnosis and real medical and social needs neglected by HSA representative **Siobhan O'Meara Kelley** and BHD representatives: Prairie Garcia, Ernesto Cervantes, Kevin Sacks, Elidia Giron and louzy crooked Court Investigator Stanford, who fabricated her report in the dark conspiracy. They stole her out of my home in 2019 when again she fell on my arms out of outrageous neglect and homelessness again. They locked her up in the homeless shelter and did not allow her to call me, talk to me, or say hello with only one goal: not to let her get my conservatorship.

Nothing good ever happened to my daughter by BHD staff, but ongoing instability, homelessness, hunger, misdiagnosis, mistreatment, mismanagement. prohibited required medical treatment, social services and education at the knowledge of PG and APS. Now she is neglected at the order of Robert Annon, controlled by Robert Annon MERT for no help, controlled by Robert Annon Sheriff's Department for refusal to deliver gravely disabled to Telecare for a professional evaluation, neglected by invisible deaf and blind psychiatrist Albert Nguyen and assigned to her another invisible deaf and blind evil MHCS Maribel Campos. **THIS COUNTY HIGH CARE!!!**

Any concerned citizen can file a grievance against premeditated damageds to vulnerable brain, mind, health and life, against outrageous disturbance of wellbeing and safety of dependent adults and co-dependent elderly, against secret conspiracy of power abuse, discrimination in treatment and retaliation against, against corruption, terror against the family, psychological and emotional torture, violation of Oath to Office, violation of Oath to Hipocrats, misdiagnosis, mistreatment, mismanagement and etc. I am not just a mother. I am another one victim, because BHD kept me co-dependent for a decade! Refusal to set up the appropriate investigation, to complete the

investigation for accountability, to make an appropriate conclusion in regards to the special needs of Autistic person that is essential, would be an intentional, knowledgeable and willful misconduct. She needs appropriate care and is licensed by CA State staff only and not strangers who are not able to get a professional license from CA State.

Every ethical county employee, who got notified about intentional, knowledgeable and willful mistreatment and mismanagement by bad authorities should help to protect vulnerable against such power abuse that allow evils taking advantage of vulnerable to get paid for egregious harm and damages and not getting held accountable.

I am sure your fellow psychiatrist, I think it was Brown, contacted you, Mr. Albert Nguyen, after my request at [REDACTED] to speak with a psychiatrist on duty that was one time honored and he spoke with me back then, maybe in August and told me that Victoria did have only one appointment with you in the year of 2024. What is the reason for 6 prescriptions that you prescribed and that my daughter suffers from all kinds of side effects, and is not able to sit still or stay without a rockin, have pain in her entire body, talking to herself nonsense, periodically screaming out loud in out of control anger and lost ability to communicate and think before acting?

Victoria was evicted from her apartment on June 10, 2021 and no one MHCS worker was willing to stay with her shoulder to shoulder to take care of that issue to prevent eviction and save all her belongings that were kept by the landlord. **NO ONE AT THE BHD WAS EVER WILLING TO PROTECT VICTORIA TODD.** The BHD, as usual, ignored all

notifications about new disasters and outrageous stress coming and her grave disability. The BHD forced that additional stress and Victoria lost everything again, not just for the first time since 2014. This is why the BHD stayed with her shoulder to shoulder to file the fraudulent RO in June 2020 against me to stop my conservatorship case [REDACTED]. BHD has no one available to evaluate her grave disability that was developed without my attempted conservatorship three times from 2014 to protect her from BHD set up disasters.

YOU ARE ALL IN To and Cc PARTICIPANTS IN INHUMAN TORTURE AND YOU ALL WISH US TO LIVE IN HELL. WHAT CAN I WISH YOU IN NEW YEAR? Have a nice day. I included a Sheriff Records call that made me sick every time I made a call in a crisis crooked by the BHD Sheriff Department.

I am Victoria's Todd mom. I am a desperate mother that is powerless to stop aggravated abuse against Autistic, Asperger disorder, naive teenager's mentality person, who was blocked by BHD for treatments after serious TBI, and was kept intentionally, knowledgeably and willfully neglected for a decade and became a **severe Autistic** with additional diagnosis **Paranoid Schizophrenia** that encountered environmentally from out of control evil power abuse.

This was sound very disrespectful by attorney Alisha Alcantar Tomovic not **to act ASAP since September 19** to protect unstable severely mentally against recurring crisis outcome of MH system neglect, the same ongoing bad influence, not to respond to any of my emails and only automated notification arrived stating that Alisha now is away. Nothing was done before the hearing **on January 6 for two identically fabricated charges two months apart**. Seems like Alisha does not care about her client as well as the entire PDO

doesn't care. Is my Autistic daughter going to be protected or also going to be neglected by the Public Defender office to continue silent assistance to the outrageous neglect of the Behavioral Health Division along with the Sheriff Department? This question is the same question that was addressed to a different PDO since 2014 for a county conservatorship and fabricated charges following that illegally obtained conservatorship 1 of 3 total. **The BHD has an irresponsible Administration** as long as I am familiar with this County BHD department for a decade. Its violent adult programs **supervisor Robert Annon** is out of control, who now manipulates even the Sheriff Department not to do their duty of delivering severely mentally disturbed Autistic to Telecare. Robert Annon also didn't allow MCRT to do their job, which denied my calls, calls from other MH workers, the call of the Nurse Practitioner from the facility to come for evaluation of gravely disabled autistic, and **the transfer from Santa Rosa Behavioral Hospital for stabilization also was refused on or after October 22**. BHD's Administration and Robert Annon's goals for a decade were to degrade my vulnerable daughter, not allowing her to be under required licensed supervision for stabilization and monitoring of the effect of dangerous psychiatric medication, instead set up intentional neglect for failure of housing and benefits. The Human Services Department continues to fabricate denials for CalFresh and IHSS.

Victoria's independence was killed completely since she became a client of BHD. This ongoing and obvious misconduct is going on **covered up by the Quality Improvements Department** and all together the county evil employees **continue blocking her from Medicare and SS benefits, from Mobile Crisis Response Team help in crisis, from Telecare crisis center, from any good mental health facility for stabilization that really helps to get back to function.**

This is obvious and ongoing discrimination against Autistic that is incapable of standing up against abuse and protecting herself and retaliation for my valid complaints against power abuse for outrageous neglect that never got any attention to keep both of us suffering. And APS usually and silently allows the abuse of elderly in addition to abuse of the dependent adult.

COORDINATION INTENTIONALLY ABSENT, AND STABILIZATION NEVER WAS ALLOWED. MY DAUGHTER GOT LOST AND I LOST MY DAUGHTER! THAT IS INHUMAN.

I do not wish any of you to have the same experience with a lost out of reality child. I do not wish you to get your life stolen, but ours were stolen.

It is already at least a month like **CARE Court** supposed to be used, but nothing is done against the totalitarian abuse of the Santa Cruz County Behavioral Health Division covered up by Law Enforcement that continues to block **Mobile Crisis Team Response** to respond to my calls. I couldn't get a response for 3,5 last year. They also ignore reports and calls from professionals who are not BHD employees, but who tried to help me. The Public Defender office, historically in my family experience since 2014, does nothing to protect the wellbeing and safety of my daughter. The Santa Cruz County Departments on **Emeline** have on payroll a lot of none licensed by CA State DCA, and operate by a bunch of incompetent and unprofessional creatures. **It is against the law** to hire unlicensed, incompetent and unprofessional people for highly paid professional positions to serve vulnerable people in the community. From newspaper Santa Cruz Locals: "**Karen Kern, deputy director of the Behavioral**

Health Division of Santa Cruz County's Health Services Agency, doesn't think CARE Courts are going to solve the problem for everybody who's experiencing homelessness in our county." Karen Kern is preparing the community for no success because the BHD Administration are not qualified to be in charge of leadership as they do not possess professional CA State BSB licenses as they are obviously not able to obtain it. They are only able to do what they always did to help criminals to use the CARE Court to get away from punishment and accountability, just like they cover up each other's inability to perform their duty according to their positions.

My Autistic daughter got blocked from all social services and isn't allowed treatments for recovery to recover from their psychiatric unmonitored abuse and outrageous intentional neglect that is going unstoppable for a decade. BHD Administration does not have CA State BSB licenses as follows: **Karen Kern - Deputy Director and Tiffany Cantrell Waren - BHD Director. Their incompetence** covered up by licensed clinical social worker **Sube Robertson - Director of Quality Improvements Department**, who totally and intentionally ignored the needs of Autistic and blocked my daughter's medical records from Medicare, SS and IHSS benefits. **Sube Robertson** totally ignores family complaints and inquiry community members about **BHD mistreatment, mismanagement and intentional neglect** by "special unlicensed" bunch of unprofessional, uneducated, incompetent, but professional crooks that were hired for **Mental Health Client Specialist (MHCS)** position, without a professional license. That bunch of unlicensed MHCS covered up and led by licensed **evil Robert Annon - BHD manager of adult program**, who knowledgeable covering up the failure of MH system to hell and instructing Law Enforcement what to do and what not to do to help BHD to **terrorise my vulnerable daughter and create out of her gravely disabled**. Every time I complained about the power of abuse for misdiagnosis, mistreatment and mismanagement it was

getting worse. Retaliation is following after discrimination. My initial complaints against the former BHD administration, also against unlicensed by CA State DCA Erik Riera - BHD Director, Pamela Rogers Wyman - BHD manager of adult program, who finally retired without accountability along with unlicensed Public Guardian Vanessa Bertsche Shelton. Unlicensed Conservators Vivian Van Dal and Mareen Clawson. The unlicensed MHCS Prairie Garcia, Ernesto Cervantes, Maribel Campos, and licensed MHCS Kevin Sacks and Elidia Giron, who all get highly paid to inject a corrupt mind program into my daughter's mind. They were making a mockery over innocent vulnerable Autistic, all like one manipulated autistic to create Paranoid Schizophrenic Zombie after first county conservatorship by forcing county BHD client into homelessness and hunger to develop grave disability and with Law Enforcement fabricated a charge of 148(a) without an actual crime against gravely disabled, while she was listed as a missing person on CA State AG records for months.

No one Public Defender was or is willing to do their job to protect their client from anarchy and chaos against escalated psychitric brainwash, psychological and emotional torture. Since 2014, county PDO was helping county BHD and APS three times to kidnap my daughter into human trafficking for illegal heavy brainwash, to torture Autistic Asperger for decade in violent isolation and alienation. Since 2014, BHD denied my constant requests to transfer autistic to San Andreas services, who also is not native American born. The BHD's only goal was and is to divide the vulnerable from family, isolate her to be in power of coaching to act against own wellbeing and safety, see all good as bad and bad as good without family assistance and protection, in addition to blocked learning process and education for independence. Her life was stolen. She has been threatened and gets scared by power adapting her to abuse and

life without stability and out of public benefits.

As a result of such abuse, my autistic daughter has lost the ability to think critically, evaluate, analyse which keeps her in constant danger to herself by her actions on impulse, in the rush without thinking, lost ability to communicate, listen to learn from different opinions, ability to participate in discussion, but running away with closed corrupted mind from everything that is good for her wellbeing and safety, peace, quiet and joy. Her corrupted mind, sadness and out of control anger on a daily basis against her life and against my life since she became a BHD client. BHD's one sided power to torture prohibiting any other doctor or medical professional to accept her for treatment, so MCTR is the first on the black list than Telecare and so on. **It is against the law for county employees not to admit transparency, accountability, and duty in violation to Oath to Office.** Why is there no investigation allowed against unfair practices by the BHD? Telecare Crisis Center and Mobile Crisis Team Response services under BHD leadership denied my calls in crisis, calls for appropriate rehabilitation services to my daughter, ignoring my valid complaints and my 911 calls.

We are in danger! The BHD, APS, HSA respond now that my daughter is an adult and they cannot force her for treatment. They refuse to admit that they never did provide good services and never invited her to learn what is good and what is bad. Now they deny the care for gravely disabled severe Autistic that they created by intentional damages out of my productive and functional daughter that I raised. This is why they constantly deny IHSS services to help the family and deny help in times of crisis. We are harmed by the egregious mockery. I have not just one story book about a concentration camp

under Santa Cruz County Behavioral Health Division and you people think that the same people will make a difference? The new law was supposed to start working on December 1 and it is some kind of employee Rosi G. that did not provide me with her last name, but she incompetent creature that pick up the crisis phone line and want me professionally to describe the behavior of Paranoid Schizophrenic whose brain gets on fire occasionally. Numerous of times, totally incompetent Rosi, was hanging up on me and refused to connect me with Mobile Crisis services, helping them to hide and leave us to continue to suffer. Nothing changed yet and never will without accountability. Those highly paid county employees are lazy or scared of the vulnerable, because they are not able or unwilling to take care of the gravely disabled, or do not have skills to comfort gravely disabled to communicate for help to start stabilization. Only when they can earn vulnerable trust can they interact with them about a new, normal life.

For a decade the county Board of Supervisors makes me to write hundreds of complaints that they premeditatedly ignoring to escalate stress to damage our nervous system and brain that shortening mine and my **severe Autistic** daughter's lives by refusing **to stop inhuman torture** by the county BHD administration's ignorance to valid complaints requesting a treatment plan for stabilization. There are obviously not enough decent people in government to make improvements and changes for good. County bad employees occasionally get retired and always get applause and farewell honors. Former **Sheriff Jim Hart**, was the one whose department terrorized my family with no stop for a decade by this day refusing to protect our property, peace, quiet and joy in our home. The DA isn't enforcing the Law against abuse and unaccountability of county employees, instead **DA Jeffrey Rosell** assisting and actively helps criminally minded county employees and career criminals on probation to attack their victims, escalating abuse by connections and power of the **DA Inspector Steven Ryan**. My severely Autistic daughter who was diagnosed with Paranoid Schizophrenia last time **at the Santa Rosa Behavioral Hospital on October 15-22 was thrown** into my arms back again, away from stabilization, without a treatment plan. My daughter's mind, brain, soul and life have been psychologically and emotionally in deep ongoing crises and in obstruction from available real treatment and recovery **by abuse of CA STATE**

UNLICENSED BHD COUNTY MHCS during the decade. The criminal syndicate within BHD transferred her from human trafficking for heavy brainwash, prohibited the second doctor's opinion and excluded from wellbeing and safety by blocking any therapy for pain relief, side effects, depression, drug addiction that started with OXYCODONE, and moved to psychiatric drugs out of monitoring and torture by drug dealers and sex trafficking dealers that Sheriff Department refused to protect against.
