Illegal Dumping / Litter Abatement Program


- Bulky item pick-up program (GreenWaste) has been successful in reducing illegal dumping
 - 6,300 bulky items collected via curbside collection in 2024 (up 754 events from 2023)
- Community Partnerships
 - Downtown Streets Team (DST)
 - Watsonville Works
 - Save Our Shores
 - Trash Talkers (Pitch-In Santa Cruz Campaign)
 - County Parks
 - Roads Litter Crews
 - Sheriff's Department
- Education and outreach efforts
 - GreenWaste truck signs, frequent TV and radio ads, and a social media presence
 - Zero Waste Newsletters to GreenWaste customers by sector
 - Convenient reporting system for timely removal (My Santa Cruz County app)
 - Various tabling events including Earth Day events



Illegal Dumping

- 855.02 Tons of material collected from public spaces in 2024 (\$82,936.94 in lost revenue if properly disposed)
 - 820.7 Tons of Illegal Dumping material cleaned up by Roads Special Crews in 2024
 - 19.23 Tons of Litter cleaned up by Roads Special Crews in 2024
 - 12.4 Tons of Litter cleaned up Downtown Streets Team
 - .68 Tons (1,500 pounds) of Litter cleaned up during First Annual Santa Cruz County Pitch-In Cleanup event
 - 2.01 Tons of Litter cleaned up during 2023-24 FY by volunteers during Save Our Shores Cleanup Events
- \$456,600 projected for 2024-25 FY spent on Illegal Dumping by CDI


Recycling and Solid Waste Illegal Dumping Costs



Litter Abatement

- \$865,450 projected for 2024-25 FY spent on Litter Abatement by CDI
 - Street Sweeping - \$515,000
 - Roads Crews Litter Abatement - \$130,000
 - Downtown Streets Team - \$165,000
 - Watsonville Works - \$18,000
 - Save Our Shores - \$37,450

Enforcement

- Code Enforcement
 - High-powered cameras have been deployed at hotspots throughout the County, and can be relocated with ease
 - New Code Compliance Investigator started on November 25, 2024
 - 1 active case with a misdemeanor warrant issued by Sheriff's Office for activity caught with cameras
- Current Fine Schedule for Illegal Dumping
 - \$100 for 1st offense
 - \$200 for 2nd offense within same year
 - \$500 for all subsequent offenses within same year
- Proposed Fine Schedule for Illegal Dumping
 - \$2,500 for 1st offense
 - \$5,000 for 2nd offense within same year
 - \$10,000 for all subsequent offenses within same year
