### **Recommended Actions**

1. Consider report on efforts to protect and support immigrant and LGBTQ+ communities in Santa Cruz County;
2. Direct the County Administrative Office (CAO) to work with the Health Services Agency (HSA) and Human Services Department (HSD) to allocate \$100,000 for undocumented immigrant legal services and \$100,000 for LGBTQ+ community support services;
3. Approve the transfer of appropriations in the amount of \$200,000 from General Fund Contingency for immigrant legal and LGBTQ+ support services, and authorize the CAO to implement the transfer to HSA and/or HSD pending identification of community-based organizations to deliver services; and
4. Direct the CAO to return on or before June 10, 2025, with an update on protecting and supporting immigrant and LGBTQ+ communities residing in Santa Cruz County.

### **Executive Summary**

In December 2024 and January 2025, the Board of Supervisors adopted Resolutions 279-2024 and 4-2025, reaffirming Santa Cruz County's commitment to protecting and supporting immigrant communities as a sanctuary county and reaffirming Santa Cruz County's commitment to protecting, serving, and supporting lesbian, gay, bisexual, transgender people and people with other gender and sexual identities (LGBTQ+) in their pursuit of health, happiness, and private exercise of bodily autonomy. As an immediate step to further these commitments, staff recommends transferring \$200,000 from General Fund Contingency, with \$100,000 dedicated to undocumented immigrant legal services and \$100,000 dedicated to LGBTQ+ community support services.

### **Discussion**

On December 17, 2024, the Board of Supervisors adopted Resolution 279-2024, reaffirming Santa Cruz County's commitment to protecting and supporting immigrant communities as a sanctuary county. Subsequently, the Board adopted Resolution 4-2025, reaffirming Santa Cruz County's commitment to protecting, serving, and supporting LGBTQ+ individuals and women in their pursuit of health, happiness, and private exercise of bodily autonomy.

These resolutions affirmed the County's role in ensuring that immigrant residents have access to necessary resources and protections against policies that may negatively impact their safety and well-being and emphasized the County's dedication to ensuring continued access to services that allow LGBTQ+ individuals and women to lead healthy and fulfilling lives, free from fear of discrimination or retaliation. The Board also directed the County Administrative Officer to work with community partners to identify opportunities to strengthen resources available to support these communities and maintain and expand essential services.

Recent federal policy changes are targeting undocumented immigrant and LGBTQ+ communities with impacts both local and nationwide, giving rise to an immediate need for resources to protect the health and wellbeing of these county residents. As an immediate step to further these commitments, staff recommends transferring \$200,000 from General Fund Contingency, with \$100,000 dedicated to undocumented immigrant legal services and \$100,000 dedicated to LGBTQ+ community support services. The CAO will work expeditiously, in collaboration with HSA and HSD, to identify community-based organizations (CBOs) to deliver these services, and requests the Board's authorization to implement the transfer of appropriations pending this work. The County has a variety of contracts already in place with CBOs through HSA and HSD, so one or more of these contracts may serve as the mechanism for these additional services.

Additionally, at the State level, Senate Bill No. 2 (SB 2) was signed by the Governor on February 7, 2025, and filed with the Secretary of State on the same day. SB 2 amends the California Budget Act of 2024 to allocate additional State funding for civil legal services and immigration-related support. Specifically, it appropriates \$10 million to the Judicial Council for grants to legal service organizations aiding indigent individuals facing deportation, eviction, wage theft, and other legal challenges; \$10 million to the California Department of Social Services for immigration-related services, including removal defense; and \$5 million to the Judicial Council for grants through the California Access to Justice Commission to support nonprofit legal service providers. Grant funds will be available for encumbrance until June 30, 2026, and for expenditure until June 30, 2028.

The bill takes effect immediately, but the State has not yet released specific criteria detailing how the funds allocated under Senate Bill No. 2 will be distributed. The CAO will track this information, including specific criteria for grant eligibility, application processes, and timelines for disbursement, as it is released by the responsible agencies. The CAO will return on or before June 10, 2025, with an update on SB 2 implementation and local efforts to protect and support immigrant and LGBTQ+ communities.

### **Financial Impact**

The recommended actions will result in a \$200,000 transfer from the General Fund Contingency to support undocumented immigrant legal services (\$100,000) and LGBTQ+ community support services (\$100,000). No new revenue sources are identified at this time, and the General Fund Contingency budget will be reduced by \$200,000 with the transfer of appropriations for immigrant legal and LGBTQ+ community support services (GL Key 131375 Object 98700). With the Fiscal Year 2024-25 budget adjustments recommended in the mid-year report, the General Fund Contingency budget has available appropriations of \$7,107,282, excluding the \$1 million restricted contingency for winter storm damage response.

Supervisor Cummings,

As a member of the Welcoming Network, as the child of immigrants, as a local Santa Cruz community member, and as a citizen of our USA, I urge you to increase funding for immigration services from \$100,000 to at least \$150,000. With an estimated 16,000 undocumented individuals in Santa Cruz County, the need for legal, financial, and emotional support has never been greater.

The Santa Cruz County Immigration Coalition (SCCIC), informed by input from over 120 direct and indirect service providers, has identified the following urgent priorities:

- **Deportation Defense Fund (\$25K)** – Legal support for families facing deportation is essential to keeping our communities intact.
- **Bail Bond Fund (\$20K)** – Ensuring access to bail prevents unnecessary detention and family separation.

- **Household Support Fund (\$10K)** – Deportation disrupts entire households, leaving families struggling to meet basic needs.
- **Legal and Educational Services (\$55K)** – Families need access to immigration pathways education, personalized case assessments, and legal document preparation.
- **Family & Child Safety (\$25K)** – Childcare and asset planning help families prepare for the unthinkable, ensuring children’s well-being and financial security.
- **Mental Health & Community Support (\$15K)** – The fear and trauma of deportation impact mental health, and community-based infrastructure, such as rapid response networks, help keep families informed and safe.

The current \$100,000 allocation is simply not enough to meet these growing needs. Increasing funding to at least \$150,000 is a necessary step toward ensuring the safety, stability, and dignity of our undocumented community members—individuals who contribute so much to our local economy and culture.

In these very scary times, I urge you to lead with compassion and justice by increasing this allocation.

Dear friends,

I am sorry that I will not be able to speak on this item at the meeting tomorrow. I'm sending this notes hoping to ensure that you have a chance to review my comments. By way of introduction to those whom I have not been able to meet: I am a retired public sociologist. In the past I engaged intensely with the Board during community efforts to end past-Sheriff Wowack's use of our jail to hold our neighbors for deportation; I subsequently helped your predecessors draft the language for your sanctuary policy. More recently I am active in the Santa Cruz Welcoming Network. Earlier, while serving as a consultant to Santa Clara County, I helped that county launch the first local office of immigrant affairs in the country.

Throughout these years I have consistently advocated, in many published Op Eds and other forum, for expanded county leadership in immigrant affairs. So I support and applaud your action. I'd also ask you to consider this a first step: please do not stop here. Perhaps you might consider several questions:

1. Will LGBTQ+ support services begin to include support for refugees fleeing to our community due to persecution for their gender identities?
2. Some other California counties have long provided much more funding and leadership in public planning for immigration legal services. Will our county's commitment will be similarly sustained and expanded?
3. By itself this amount of support will not have a significant impact on representation for vulnerable families given the scale of need unless it is part of a meaningful planning effort. Will your staff begin to provide public leadership to build regional capacity in this field?

4. Specifically: might the funds could be allocated through a process that includes needs assessment that leads to a planning process, including identifying additional sources of support and promotes collaborative services and fundraising similar, again, to other counties?

5. Finally: It's widely recognized that our county boundaries are artificial barriers to good planning and community services, especially for immigrant communities centered as they are in the Salinas Valley. Combined public support can help overcome barriers to collaboration, and regional planning can leverage much more significant levels of foundation support. So I can you please direct county planners to engage with their counterparts in the 4-county region that includes Monterey, Santa Cruz, San Benito and south Santa Clara counties to convene and steer a regional planning effort?

I'd like to note that at a January convening of immigrant-serving agencies on the central coast, Attorney General Bonta advised us that major public foundations which put millions of dollars annually into rural community development in California have approached him to ask where, given these new circumstances, they should direct "a lot of money". He said he had advised them to fund rural immigration legal services in areas like the central coast. I sincerely hope that through collaboration and public leadership YOU can leverage our county's support in a way the makes a meaningful difference in this deeply under-served region.

I appreciate the Board of Supervisors consideration of allocating funds to protect and support Santa Cruz County immigrants. A decision to allocate significant funding proves the Board's commitment as a sanctuary county.

I request the Board direct the County Administrative Office to actively seek State funds as soon as specific criteria for grants is released, as \$100,000 will not be sufficient for Santa Cruz Couty undocumented immigrant legal services.

The Santa Cruz County Immigration Coalition (SCCIC), has already been working on undocumented immigrant legal services. SCCIC can assist the Health Services Agency and Human Services Department in planning and implementing protection and support for our undocumented immigrant residents. Specifically, the funds should be allocated through a process that includes needs assessment and that promotes collaborative services and collaborative fundraising among agencies with the capacity to provide expanded immigration legal services. SCCIC, informed by input from direct and indirect service providers, has identified the following urgent priorities:
