Recommended Actions

Defer to June 24, 2025, an update on protecting and supporting immigrant and LGBTQ+ communities residing in Santa Cruz County.

Executive Summary

On February 25, 2025, the Board directed the County Executive Office (CEO) to return on or before June 10, 2025, with an update on protecting and supporting immigrant and LGBTQ+ communities residing in Santa Cruz County. Additional time is needed to prepare the update. CEO staff recommends deferring the report to the June 24, 2025, Board meeting.

Discussion

On February 25, 2025, the Board took action to protect and support immigrant and LGBTQ+ communities by directing the CEO to work with the Health Services Agency (HSA) and Human Services Department (HSD) to allocate \$100,000 for undocumented immigrant legal services and \$100,000 for LGBTQ+ community support services, using appropriations from General Fund Contingency, with services to be delivered by community-based organizations. Additionally, the Board directed the CEO to return on or before June 10, 2025, with an update on protecting and supporting immigrant and LGBTQ+ communities residing in Santa Cruz County. Additional time is needed to prepare the update; and CEO staff recommends deferring the report to the June 24, 2025, Board meeting.

Although additional time is needed to develop a more comprehensive update, staff is able to report that since the Board's February direction to allocate \$200,000 from General Fund Contingency, HSD and HSA have executed agreements with several community-based organizations to provide services to immigrant and LGBTQ+ communities. The agreements are listed in Table 1 below.

Staff recommends returning on June 24, 2025, with a more detailed update on efforts to protect and support immigrant and LGBTQ+ communities residing in Santa Cruz County.

Financial Impact

The Board direction on February 25, 2025 resulted in a \$200,000 transfer of appropriations from General Fund Contingency to support undocumented immigrant legal services (\$100,000) and LGBTQ+ community support services (\$100,000). Deferral of this update will not result in new financial actions or impacts.
