Meeting Date: June 10, 2025

Formal Title: Adopt resolution condemning the use of military force in civilian communities and affirming the constitutional rights of all residents, and take related actions

Recommended Actions

1. Adopt the attached resolution condemning the use of military force in civilian communities and affirming the constitutional rights of all residents; and,
2. Direct the Clerk of the Board to transmit copies of this resolution to Governor Gavin Newsom, the County's State and federal legislative representatives, and to neighboring counties and municipalities, urging them to adopt similar measures.

Executive Summary

This urgency resolution reaffirms Santa Cruz County's commitment to the constitutional and human rights of all its residents. It responds to escalating concerns regarding the use of military force in civilian contexts, particularly where such force is directed toward immigrant and marginalized communities. The resolution condemns militarized responses within communities, calls for the cessation of such practices at the State and federal levels, and urges neighboring jurisdictions to take similar action. The need to take immediate action to adopt this resolution came to the attention of the County after the agenda was published.

Discussion

The United States and California Constitutions provide robust protections for individual liberties, including the rights to freedom of speech, assembly, due process, equal protection, and freedom from unwarranted searches. These rights are undermined when military force or tactics are deployed in civilian communities. This concern was brought into sharp focus by President Trump's recent decision to deploy the National Guard in Los Angeles over the weekend without any consultation with the Governor of California or the Mayor of Los Angeles. Such unilateral action bypasses local and State authority, exacerbates public fear, and raises serious constitutional and democratic concerns. The resolution highlights the harmful impact of militarized enforcement on public peace, mental and physical health, and community trust, particularly among immigrants and other vulnerable populations. These practices not only escalate tensions but also destabilize community safety and erode democratic principles.

RESOLUTION CONDEMNING THE USE OF MILITARY FORCE IN CIVILIAN
COMMUNITIES AND AFFIRMING THE CONSTITUTIONAL RIGHTS OF ALL
RESIDENTS

WHEREAS, the Constitution of the United States guarantees fundamental rights to all people, including freedom of speech and assembly, due process, equal protection, and freedom from unwarranted searches and seizures, as enshrined in the First, Fourth, Fifth, and Fourteenth Amendments; and

WHEREAS, the California Constitution affirms that all persons are by nature free and independent and have inalienable rights, including the rights of privacy, liberty, safety, and happiness (Article I, Section 1); and

WHEREAS, the use or threat of military force in civilian communities, particularly immigrant and marginalized communities, undermines those constitutional guarantees and creates conditions of fear, instability, and trauma that threaten the public peace and safety; and

WHEREAS, the deployment of military resources or personnel in local neighborhoods for policing or intimidation constitutes an excessive show of force that may provoke unrest, escalate tensions, and jeopardize the mental and physical well-being of residents; and

WHEREAS, such actions disproportionately impact vulnerable populations, including immigrants and refugees, who may already experience heightened fear of government authorities and are at risk of harassment, discrimination, or violence; and

WHEREAS, the normalization of militarized law enforcement responses and the targeting of immigrant communities erodes trust between residents and local government, and threatens the constitutional fabric of our democracy; and

WHEREAS, the Santa Cruz County Board of Supervisors finds that adoption of this resolution supports preservation and protection of the public

peace, health, safety and constitutional rights of all residents in the face of escalating federal threats of militarized enforcement;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Santa Cruz County Board of Supervisors that:

1. The Board condemns the use of military force in civilian communities within and beyond Santa Cruz County.
2. The Board affirms its unwavering support for the constitutional and human rights of all individuals residing in Santa Cruz County, regardless of immigration status or background.
3. The Board urges State and federal officials to immediately cease all actions that militarize law enforcement or target immigrant communities, and instead prioritize policies rooted in community safety, human dignity, and equality.
4. The Clerk of the Board is directed to transmit copies of this resolution to Governor Gavin Newsom, the County's State and federal legislative representatives, and to neighboring counties and municipalities, urging them to adopt similar measures.

From time to time, County of Santa Cruz (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee.
