Recommended Actions

1. Adopt resolution approving Nancy Miller Gomez to serve as the 2025-2026 Santa Cruz County Poet Laureate; and
2. Authorize the Director of Parks, Open Space and Cultural Services or designee to take necessary actions to support the Poet Laureate in implementing poetry programming county-wide

Executive Summary

The Department of Parks, Open Space & Cultural Services (Parks), with the support of the Santa Cruz County Arts Commission, is requesting that the Board approve Nancy Miller Gomez as the 2025-2026 Santa Cruz County Poet Laureate and appoint her to the honorary two-year position.

Discussion

The Santa Cruz County Laureate position was approved by your Board on October 18, 2022. Farnaz Fatemi, 2023-24 County Poet Laureate, has completed her two-year appointment to the position. The 2025-26 County Poet Laureate application period was open through October 30, 2024 and several local poets applied for the position. A seven-member selection panel convened by Santa Cruz Public Libraries staff and comprised of a County Arts Commissioner, an Arts Council Board Member, a previous Poet Laureate, a poetry student, a spoken word poet, a member of Writers of Color Santa Cruz County, and a community member reviewed the applications at their November meeting and selected Nancy Miller Gomez to recommend for the position. Should she be approved by the Board to serve as Santa Cruz County Poet Laureate for 2025-26, she will use poetry to bring people together not only for connection, but for opportunities to build bridges and to engage with one another in ways that are deeply meaningful.

The arts are essential to a community's vitality and economic development, and appointing Ms. Miller Gomez to the Poet Laureate position will elevate poetry in our community, educate the public about the value of creative expression, inspire diverse voices to emerge, create new points of connection among residents in our county, and increase access to our cultural resources. The County Poet Laureate cultivates the arts in accordance with Objective 2.5 (Partnerships), and Objective 3.2 (Arts) of the Parks Strategic Plan.

RESOLUTION APPROVING THE DESIGNATION OF NANCY MILLER GOMEZ AS
SANTA CRUZ COUNTY 2025-2026 POET LAUREATE

WHEREAS, the Santa Cruz County Poet Laureate position was approved by your Board on October 18, 2022, with the objective to elevate poetry in our community, educate the public about the value of creative expression, inspire diverse voices to emerge, create new points of connection among residents in our county, and increase access to our cultural resources; and

WHEREAS, in collaboration with Arts Council Santa Cruz County, Santa Cruz Public Libraries, Santa Cruz County Parks, and Poetry Santa Cruz, the application process for this honorary position was developed, and a seven-member panel convened to review applications; and

WHEREAS, the selection panel reviewed the applications and, in November 2024, selected Nancy Miller Gomez to be recommended for the Santa Cruz County Poet Laureate for a two-year term, from January 31, 2025 to December 31, 2026; and

WHEREAS, her work has appeared or is forthcoming in many publications, among them *Best American Poetry*, *Best New Poets*, *Prairie Schooner*, *TriQuarterly*, *The Adroit Journal*, *The Hopkins Review*, and she received a special mention in the *2023 Pushcart Prize Anthology* and her chapbook, *Punishment*, was published as part of the *Rattle* chapbook series; and

WHEREAS, Nancy Miller Gomez co-founded an organization that provides writing workshops to incarcerated women and men and has taught poetry in Salinas Valley State Prison, the Santa Cruz County Jails and the Juvenile Hall; and

WHEREAS, during her two-year term as Santa Cruz County Poet Laureate, Nancy Miller Gomez will work to coax poetry off its academic pedestal and bring it back to members of the community who have little to no experience with poetry, and especially to those who have been marginalized and are most in need of the connective lifeline that poetry offers;

NOW, THEREFORE, BE IT RESOLVED that, the Board of Supervisors of the County of Santa Cruz does hereby approve Nancy Miller Gomez as Santa Cruz County's Poet Laureate from January 31, 2025 through December 31, 2026, and honor her for her significant contributions to advancing and enlivening the art of poetry in Santa Cruz County.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Santa Cruz (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact County of Santa Cruz:

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from County of Santa Cruz

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to nada.algharib@santacruzcounty.us and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with County of Santa Cruz

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to nada.algharib@santacruzcounty.us and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software
