### **Executive Summary**

Chapter 2.88 of the County Code establishes the Deferred Compensation Advisory Commission. The Commission consists of eight members appointed by the Board upon nomination by County officials and organizations specified in the ordinance, including the Middle Management Association (MMA). The MMA representative is recommended to be filled by Monica Rocha, Administrative Services Manager.

### **Discussion**

County Code Chapter 2.88 establishes the Deferred Compensation Advisory Commission. The Commission consists of eight members appointed by the Board upon nomination by County officials and organizations specified in the ordinance, including the Personnel Director. The Commission is responsible for the operation of the County deferred compensation plan, according to its terms and conditions and applicable regulations.

One member shall be nominated by each of the following officials and organizations: the County Administrative Officer, the County Counsel, the Personnel Director, the Santa Cruz MMA, the Service Employees International Union, and the Deputy Sheriff's Association. Two members shall be nominated by the Auditor-Controller-Treasurer-Tax-Collector; one of whom shall be the employee of that office responsible for directing County investment activities.

Board approval is requested to appoint Monica Rocha, Administrative Services Manager, as the MMA's representative on the Commission.
